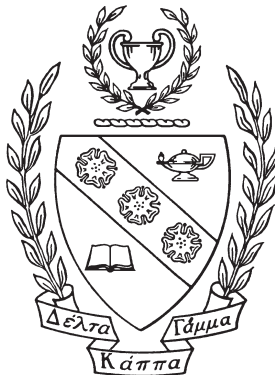

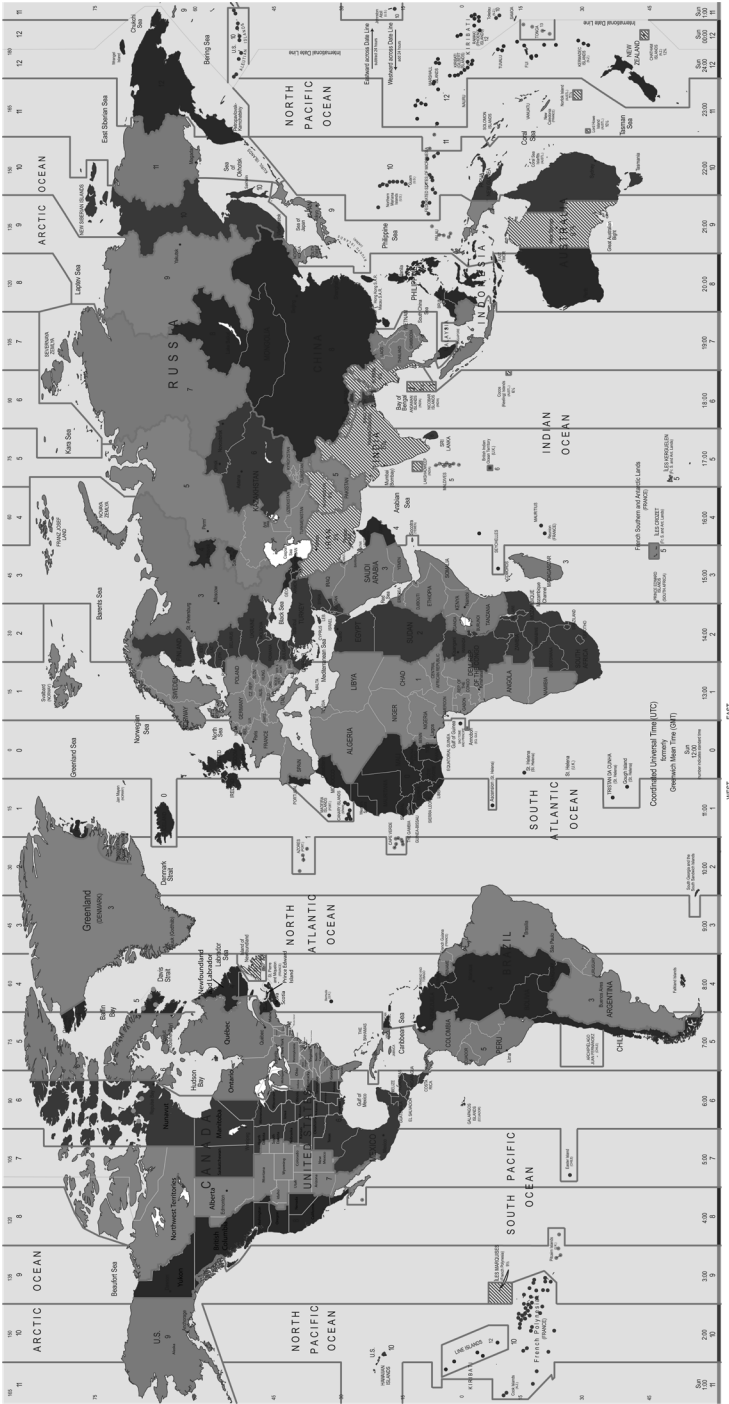


Example 1: To call from the United States to the United Kingdom
